The following aspects were discussed:/
Die volgende aspekte is bespreek:

- **MFMA circular 63:** Oversight committee recommended that this circular be tabled at council in order to get clarification on whether the administration could adhere to the requirements./
MFMA omsendbrief 63: Oorsigkomitee het aanbeveel dat hierdie omsendbrief aan die Raad voorgelê word om duidelikheid te verkry of die administrasie aan die vereistes kan voldoen.
- **Underexpenditure of capital budgets:** Certain external factors hampered the ability of the Technical Directorate to spend capital funds. These include:
 - The Greyton/Genadendal Link Sewer project which had to be put on ice due to the interference of the Transformation Committee of Genadendal after official authorization was received from the Minister of Traditional Affairs and Land Transformation.
 - Under performance of the Civil Contractor for Phase I at the Grabouw Waste Water Treatment Plant, Nammic, this delayed progress for more than 2 months.

Onderbesteding van kapitaalbegrotings: Sekere eksterne faktore het die vermoë van die Tegniiese Direkoraat om kapitaalfondse te bestee, belemmer. Dit sluit die volgende in:

- Die Greyton/Genadendal Koppelrioolprojek wat ter syde gestel moes word as gevolg van die inmenging van die Transformasiekomitee van Genadendal nadat amptelike magtiging van die Minister van Tradisionele Sake en Grondtransformasie verkry is.
 - Onderprestasie van die Siviele Kontrakteur vir Fase I by die Grabouw Afvalwaterbehandelingsaanleg, Nammic. Dit het vordering met meer as 2 maande vertraag.
- **Protest Actions:** The so-called Service Delivery Protest Action in all our towns had a serious impact on the stability and normal functioning of the

municipality. It caused disruption within the organization and of service delivery in general. This resulted in the Administration being more reactive and was forced into a crisis management mode. In many instances priorities had to be reviewed and certain services and communities started receiving less attention. It was not as a result of a deliberate decision or by choice but more as a result of the crisis management situation that gradually developed. /

Protes-optrede: Die sogenaamde Diensleweringprotes-optrede in al ons dorpe het 'n ernstige impak op die stabiliteit en normale funksionering van die munisipaliteit gehad. Dit het ontwrigting in die organisasie en in dienslewering in die algemeen veroorsaak. Dit het daartoe gelei dat die Administrasie meer reaktief opgetree het en in krisisbestuur gedwing is. In baie gevalle moes prioriteite hersien word en sekere dienste en gemeenskappe het minder aandag begin ontvang. Dit was nie as gevolg van 'n doelbewuste besluit of keuse nie, maar eerder as gevolg van die krisisbestuursituasie wat geleidelik ontwikkel het.

- **Contract Management:** Project management is under strain. In order to improve capacity in the Technical Directorate, a contract management unit will be established. This section will focus on project management in all departments of TWK./

Kontrakbestuur: Projekbestuur is onder druk. Ten einde kapasiteit in die Tegnieuse Direkoraat te verbeter, sal 'n kontrakbestuurseenheid daargestel word. Hierdie afdeling sal fokus op projekbestuur in alle departemente van TWK.

- **Status Quo on Water and Sanitation Services:** The Blue Drop and Green Drop outcome for the 2011/12 financial year must be included in the Annual report./

Status Quo van Water- en Sanitasiedienste: Die 'Blue Drop' en 'Green Drop' uitslag vir die 2011/12 finansiële jaar moet in die Jaarverslag ingesluit word.

- **Water Staff Capacity:** Due to the recent crisis in Grabouw wrt the water supply, it is recommended that the capacity of the water personel in Grabouw be addressed as a matter of urgency./

Waterpersoneelkapasiteit: As gevolg van die onlangse krisis in Grabouw met betrekking tot watertoevoer, word aanbeveel dat die kapasiteit van die waterpersoneel in Grabouw dringend aangespreek word.

- **Public Participation Processes:** Mr Isaacs: Director Corporate Services must look into a different approach of consulting with community members of Genadendal who where not part of the original public participation processes with the transformation committee. It is felt that their perceptions might differ from that of the Transformation Committee./

Openbaredeelnamesproses: Mnr. Isaacs: Direkteur Korporatiewe Dienste moet 'n ander benadering ondersoek om gemeenskapslede van Genadendal wat nie deel van die oorspronklike deelnameproses met die transformasiekomitee uitgemaak het nie, te raadpleeg. Daar word gevoel dat hulle persepsies moontlik van die van die Transformasiekomitee kan verskil.

- **Reserve:** During the 2011/12 IDP/Budget process a special tariff was approved by council wrt building a reserve for the rehabilitation of all landfill

sites. An oversight has resulted in the tariff not being levied for the first half of the financial year. This is being corrected (claimed double) for the remainder of the financial year./

Reserwe: Gedurende die 2011/12 GOP/Begrotingsproses is 'n spesiale tarief deur die Raad goedgekeur ten opsigte van die opbou van 'n reserwe vir die rehabilitasie van alle grondopvulterreine. 'n Oorsig het veroorsaak dat die tarief nie vir die eerste helfte van die finansiële jaar gehef is nie. Dit word reggestel (dubbel geëis) vir die res van die finansiële jaar.

- **Demarcation:** Grabouw is seen as a burden to the municipality and its financial health (sustainability), as a lot of the municipality's resources is being pumped into Grabouw. It is felt that the municipal demarcations should be relooked at. Grabouw should be allocated to the City and Swellendam to Theewaterskloof./

Afbakening: Grabouw word as 'n las vir die munisipaliteit se finansiële gesondheid (volhoubaarheid) beskou, aangesien baie van die munisipaliteit se hulpbronne in Grabouw ingepomp word. Daar word gevoel dat die munisipale afbakening heroorweeg moet word. Grabouw behoort aan die Stad toegewys word en Swellendam aan Theewaterskloof.
