1. Standard Conditions of Quotation:

The following conditions will apply:

- Quotations must be completed in hand writing with black ink.
- Price(s) quoted must be valid for seven (7) days from date of order.
- **Quotations will be requested from the appointed panel of service providers for the duration of the contract. A fair rotation basis requesting of quotations will be applied.**

MBD 9 – CERTIFICATE OF INDEPENDENT BID DETERMINATION
