If posted, interested service providers to ensure that sufficient time are given for the post to reach us before the closing date and time. Council cannot responsibility for any delays.

1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Quotations must be completed in hand written non-erasable black ink.
- b) Price(s) quoted must be valid for sixty (60) days from date of closing date.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) **The goods must be delivered within one (1) week from date of official order.**
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2017 and for this purpose **MBD 2, MBD 4, MBD 6.1, MBD 6.2, MBD 8 and MBD 9** forms which are available on the Municipal Website www.twk.org.za must be completed and submitted together with your quotation.
- f) The successful provider will be the one scoring the highest points.
