#### 1. Standard Conditions of Quotation

#### The following conditions will apply:

- Quotations must be completed in handwriting with black ink.
- Price(s) quoted must be valid for at least ninety (90) days from date of your offer.
- Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- The goods must be delivered within one (1) week from date of official order.
