Fine aggregate in slurry mix i.e. (crusher dust) with limited percentage of sand.
Filler of cement in the slurry mix to be used.
Water needs to be used in mix.
Stable grade bitumen emulsion cationic SABS 548-1972 to be used for slurry.
Additive to retard the setting rate and this all depends on the road surface temperature if it's too hot as a prevention for slurry seal from becoming brittle one placed on road surface.
Slurry seal must cover all cracks on road surface where slurry application is required.
Slurry seal must be finished off with a damp bidem cloth to get a smoother finish after slurry mix is squeezed.
Site supervisor must have at least 3 years minimum road construction experience.
Slurry must be place by a specialized truck made to mix slurry and <u>not mixed by a mixer</u> machine or by hand.

SCOPE OF WORK

SUPPLY, DELIVER AND PLACEMENT OF A SLURRY OVERLAY APPLICATION AND ROAD MARKINGS, IN PLEIN STREET CALEDON.

The Contractor must ensure that work to be done includes the furnishing of all materials, plant, labour, traffic accommodation, small plant, water and equipment required to do the work for entire work for the supply, deliver placement of slurry overlay application and for road marking in Plein Street Caledon. After the slurry overlay, road marking that has been place the contractor shall ensure that construction site is cleaned up this is sweeping off lose stones and carting it away any dirt left by contractor and cleaning of kerbs that was mess during the slurry application. The Contractor must abide by the Health and Safety Practise and take full responsibility for the job, public and personnel appointed.

PROJECT SPECIFICATIONS

1 PROJECT SPECIFICATIONS

SCOPE

This Project Specification covers a general description of the project and what is expected from Contractor.

STATUS

Should any requirement or provision of the Project Specification conflict with any requirement or provision of any other specification section or clause that are applicable to the contract, the requirement or provision of the Project Specification shall prevail.

PS1 DESCRIPTION OF THE CONTRACT AND WORKS

The Work is funded by and undertaken for the Theewaterskloof Municipality.

PS2 DESCRIPTION OF SITE AND ACCESS

PS2.1 Locality

Caledon Plein street: the site is accessible by vehicle.

PS3 SITE FACILITIES AVAILABLE

PS3.1 HOUSING FACILITIES

No housing is available and the Contractor shall make his own arrangements to house his employees and for their transport to and from the Site of Works.

PS3.2 OFFICE ON SITE

No office facility is available on site and the contractor shall make his own arrangements for office facilities, if required

PS3.3 POWER SUPPLY

The contractor will be accountable for all small plants, if applicable, and no power supply will be made available for small plants, whilst work is being completed at the site.

PS3.4 TELEPHONE FACILITIES

The Contractor shall make his own arrangements for telephone facilities at the site, if required. The contractor should note that Cell Phone reception is generally available on the Site.

PS3.5 ABLUTION AND LATRINE FACILITIES

The contractor will provide his/her own ablution facilities.

PS4 FEATURES OF THE CONTRACT REQUIRING SPECIAL ATTENTION

PS4.1 APPLICATION OF SLURRY OVERLAY & ROAD MARKING

The road surface shall be lightly dampened with a fine spray of water immediately ahead of the work. The slurry mix shall be discharge onto the surface in a creamy homogenous consistency and shall roll smoothly in a continuous mass in front of the squeegee blades. As far as possible, the spreading operation shall continue without stopping. Care shall be taken to obtain smooth joints. The squeegee team shall ensure that all bare patches are covered and that any thick accumulations of slurry are levelled off or removed immediately. Patching shall be done immediately with slurry from the same batch to obtain a uniform colour. Longitudinal joints shall be carefully overlapped to avoid lean strips which shall immediately be rectified if necessary. Edges of slurry surfacing shall present clean straight lines along the line of kerbs, channels, or edges of the road.

Road marking must be done in less than two weeks of slurry seal placement has completed. Please not a temporary yield sign, stop must and solid white line must be done after slurry seal has dried. Drying time must be allowed for road marking to set before opening for traffic.

PS4. 2 PROTECTION EXISTING STRUCTURES AT WORKING AREA & TRAFFIC ACCOMADATION ON SITE

Any existing structures (i.e. existing kerbs, covering frames, channels etc.) damage by machinery of the contractor will be replaced by contractor on his/her own cost as the contractor must take full responsibility for any damages if caused by himself due to negligence's.

The contractor shall provide and maintain sufficient "road closed" boards and other signboards together with an adequate supply of beacons and flagmen for this purpose when placing slurry and roadmaking In Plein Street.

No barricades shall be permitted to remain in any road after official lighting-up time unless adequately lighted with guards in attendance.

PS4.3 TIDYING

The Contractor shall ensure that all areas worked is kept clean at all times before and after entire works are completed.

The contractor shall be responsible to clean up any spillage or windblown waste that arises and any kerbs that was spoiled by road marking, slurry.

PS4.4 DISPOSAL OF SPOIL

All spoil materials must be removed once construction phase are done.

PS4.5 HOURS OF OPERATION

The contractor to work during normal operating hours from Monday to Sunday with an approval from Theewaterskloof Official at Technical Services & Infrastructure implementation.

PS4.6 OPERATION

The Service Provider shall:

• Order and ensure the safe keeping of all the materials needed

PS4.7 PLANT

The Contractor will be responsible for all the planning and supply of the necessary plant and the Contractor must always have sufficient plant on site to carry out the required operations according to the Operational Manual. The contractor will be responsible for any delays due to small plant breakages or main plant that is required to execute work.

PS4.8 EMERGENCIES

The Contractor must be available for all emergency services and situations. The Contractor must at all times be in contact with the operators on site, either by telephone or by radio.

PS4.9 PERSONNEL

The municipality has the power to request the removal of any personnel on site that acts negligently or is not complying with his/her duties.

PS4.10 PROTECTION OF EXISTING SERVICES

Manhole covers, other services covers, kerbs and channels shall be protected by adhesive paper or other suitable means. The Contractor shall be required locate and clean all of the above mentioned services on completion of the work, to satisfaction of the Theewaterskloof employer.

PS4.11 ACCOMMODATION OF TRAFFIC

The contractor shall conduct his operation as to cause the least possible inconvenience to public traffic either by road of sidewalk. During the period of construction of the works, the contractor shall be responsible for safe and easy passage of pedestrians, animal-drawn traffic and vehicular traffic, through or over all sections of public and private roads and access to premises, which may be interfered with the operations

PS4.12 AUTHORITIES AND THE COMMUNITY

The Contractor shall comply with all the requirements of the Theewaterskloof Municipality insofar as the execution of the contract may affect or may be affected by the requirements and/or regulations of the said Authorities.

PS4.13 SITE SUPERVISION

The site supervisor must have at least 3 years' minimum experience in road construction and knowledge of road works.

PS5 EMPLOYER'S REQUIREMENTS

PS5.1 Commencement and Time for Completion

The work must commence within 15 calendar days from date of official order or as prescribed times and must be completed on a monthly basis.

PS6 MEASUREMENT AND PAYMENT

The Contractor shall submit to the Employer an invoice for the execution of the Works. Payment of such invoices shall be paid within 30 days of receipt thereof. Exemption will be made for SMME's upon request. (2 weeks for earlier payments)

I am aware that I must request the municipal representative to approve and measure any work done that will subsequently be covered by later work, before commencement of further work. Failure to adhere to this requirement will result in non-payment of the payment item in question.

Typical payment items falling within this category are the various cutting periods. The onus lies with the service provider to familiarize him/her with the quantity measurement approval requirements of all payment items before commencement of any work.

I am aware that payment will be made according to rate multiplied by the actual work done, measured in terms of the specified quality and unit of measurement description of the payment items. No payment will be affected for substandard quality.

Invoices must be submitted together with our municipal prescribed payment certificate format. Failure to comply with this requirement will result in non-payment until such stage that the payment certificate is submitted.

1.1 Additional Services

Act as the Employers agent in terms of the Occupational Health and Safety Act

The Service Provider, in submitting a tender for this contract, shall be deemed to have acknowledged acceptance of the appointment as the client's agent in terms of the Occupational Health and Safety Act, 1993 (Act No 85 of 1993) and the Construction Regulations of 2014, should the Employer accept the tender. The Service Provider shall, as such, execute all of the duties of the client as contemplated in the Construction Regulations. If the Service Provider considers it necessary to employ the services of a safety specialist in order to execute the abovementioned duties, the cost thereof must be included in the fee tendered for this project.

The Service Provider shall, apart from conducting his own activities in compliance with the Occupational Health and Safety Act, 1993 (Act No 85 of 1993) and Construction Regulations of 2014, ensure that any subconsultants/sub-contractors employed by the Service Provider also comply with the requirements of the Act and Regulations. The Service Provider shall enter into an agreement with the Employer in this regard before the commencement of any work related to this contract (Form C1.3, Part C1, Page 8 refers).

1.2 Implementation of a Quality Assurance System

(work program) the substantially address the concerns of the Employer within the time limits above. The Service Provider shall have no right to recompense in the event of such a work stoppage.

3 FORMAT OF COMMUNICATION

All requests for formal approval from the Employer, or any other body, shall be submitted in writing in hardcopy format. Interim payment claims shall be submitted in the same format, accompanied by an original tax invoice. Ad-hoc communication between the Employer and the Service Provider may be conducted per facsimile or in electronic format (e-mail).

All plans and contract documents submitted for approval shall be in both hardcopy format and agreed electronic format.

4 KEY PERSONNEL

The Service Provider is to have in its employ at the site, personnel with sufficient relevant experience in the operation of such a site.

5. EMPLOYERS RIGHT TO WITHOLD PAYMENT

The Employer reserves the right to withhold payment in the event of the contractor not complying with the provisions of the permit.


