If posted, interested service providers to ensure that sufficient time are given for the post to reach us before the closing date and time. Council cannot take responsibility for any delays.

1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Quotations must be completed in hand writing with black ink.
- b) Price(s) quoted must be valid until 30 June 2023.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) The contract will be form date of appointment until 30 June 2023.
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2017 and for this purpose MBD 2, MBD 4, MBD 6.1, MBD 8 and MBD 9 forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation.
- f) The successful provider will be the one scoring the highest points.

- h) Council may accept a quotation in full, partially, or not at all.
- i) Payments will be made not later than 30 days, after the receipt of a tax invoice.
