1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Quotations must be completed in hand writing with black ink.
- b) Price(s) quoted must be valid from **closing date until completion of works**.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) **The work must commence by no later than 16 January 2023 and be completed by 31 March 2023.**
