1. Standard Conditions of Quotation:

The following conditions will apply:

- a. Quotations must be completed in hand written non-erasable black ink.
- b. Price(s) quoted must be valid from date of appointment until 30 June 2023.
- c. Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d. The project must be completed by 30 June 2023.
- e. This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose **MBD 2**, **MBD 4**, **MBD 6.1**, **MBD 8** and **MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation.

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.
