1. Standard Conditions of Quotation:

The following conditions will apply:

- b) Price(s) quoted must be valid for sixty (60) days from closing date.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) The supply, delivery and installation must be done within two (2) weeks from date of order.
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2017 and for this purpose MBD 2, MBD 4, MBD 6.1, MBD 6.2, MBD 8 and MBD 9 forms which are available on the Municipal Website www.twk.org.za must be completed and submitted together with your quotation.
