1. Standard Conditions of Quotation:

The following conditions will apply:

- Quotations must be completed in hand written non-erasable black ink.
- Prices must be valid for at least sixty (60) days from date of your offer.
- Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- The work must be completed within two (2) months of date of official order.
- This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2017 and for this purpose **MBD 2, MBD 4, MBD 61, MBD 6.2, MBD 8 and MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation.
- The successful provider will be the one scoring the highest points.

2.1.3 Special Conditions of Contract

2.1.4 Local Content

- Only those tenderers who have fully complied with the minimum threshold per item in the Local Content Declaration are eligible to submit tenders. Refer to **Schedule 3**.

2.1.5 CIBD Grading

- In order to be considered for a contract in terms of this quotation, bidders must be registered at the Construction Industry Development Board (CIBD) and must have at least a Grading of 1GB. Please attach proof of CIBD registration.

MBD 9 – CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;

Bid rigging is, therefore, an agreement between competitors not to compete.
