THEEWATERSKLOOF MUNICIPALITY**REPEAL BY-LAW, 2016**

**Under the provisions of section 156 of the Constitution of the Republic of South Africa, 1996
the Municipal Council of the Theewaterskloof Municipality,
hereby enacts as follows:**

PURPOSE OF BYLAW

- To repeal the by-laws of the disestablished municipalities of Rivieronderend, Greyton, Grabouw, Caledon and Villiersdorp to the extent that they have been made applicable to Theewaterskloof Municipality by the authorisation of powers and functions in terms of section 84(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998).
- To repeal certain bylaws adopted by Theewaterskloof Municipality

1. REPEAL OF B-LAWS

The by-laws listed in the annexure hereto are repealed to the extend mentioned in the third column thereof.

2. SHORT TITLE

This by-law shall be called the Repeal By-law, 2016 of the Theewaterskloof Municipality.

3. OPERATIVE DATE

This by-law shall take effect on the date of publication.
