1. Proof of UIF registration / certificate;
2. COIDA letter of good standing;
3. Proof of CSD registration and compliance;
4. Compliance letter relating to your organisations registrations;
5. Registration documentation showing that the organisation is two years or older;
6. Proof of Tax exemption or Tax compliance;
7. Audited Financial Statements for the past two years;
8. Organisation constitution stamped by registering department.
