1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Quotations must be completed in handwriting with black ink.
- b) Price(s) quoted must be valid for the duration of the contract.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) The duration of this contract shall remain in full force and effect until project close out but no later than **30 June 2026**.
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the **MBD 2, MBD 4, MBD 6.1, MBD 8 & MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation subject to the test for administrative compliance.

- from the tenderer scoring the second highest points and if the second highest points scorer cannot perform on the contract, the municipality reserves the right to purchase from the tenderer scoring the third highest points.
- q) No alternative offers will be accepted.

2. Bidders Obligations:

The fee scales for services rendered in terms of the scope of works of this contract will be agreed per project in accordance with the "Guideline Scope of Services and Tariff of Fees of Persons Registered in terms of the Engineering Profession Act, 2000 (Act No 46 of 2000)" of ECSA as published in the Government Gazette No 44333 on 26 March 2021 (Vol. 669), as amended from time to time, after taking into account e.g. the project type, project value, project situation, and engineering effort. SCHEDULE 2: SCOPE OF WORKS

Project: Design, Installation, and Supervision of a Structural Portal Frame

Location: Grabouw Taxi Rank, Theewaterskloof Municipality – ERF 267

Discipline: Structural Engineering

1. INTRODUCTION

The Theewaterskloof Municipality intends to construct a new structural portal frame at the Grabouw Taxi Rank to provide a durable and weather-resistant shelter for commuters. ***The existing Portal Frame was damaged due to stormy winds (see attached drawing of previous portal frame)*** A qualified and registered Structural Engineer is required to undertake the full scope of services from conceptual design through installation supervision and final commissioning. The work must comply with all applicable South African standards, SANS codes, and local municipal requirements.

2. SCOPE OF WORK

The appointed Structural Engineer shall perform the following tasks:

2.1. Preliminary Assessment and Site Investigation

- Conduct a detailed site inspection to confirm existing site conditions, access constraints, and geotechnical considerations.
- Review any available architectural layouts, geotechnical reports, and municipal drawings.
- Assess environmental and operational constraints specific to the taxi rank's daily operations.

2.2. Structural Design

- Prepare conceptual and detailed structural designs for the portal frame, ensuring compliance with SANS
- Occupational Health and Safety Act (OHS Act)
- Any other applicable South African National Standards.
- Select appropriate structural steel sections, connections, and corrosion protection systems.
- Design for wind loads, live loads, dead loads, and potential seismic effects in accordance with the codes.
- Incorporate provisions for rainwater management, gutter support, and roofing systems.
- Coordinate with architectural requirements for aesthetics and functionality.

2.3. Project Costing, Detailed Drawings and Documentation

- Produce fully dimensioned engineering drawings, general arrangement (GA) plans, fabrication details, and erection plans in CAD format.
- Prepare reinforcement detailing (if concrete bases or footings are included).
- Provide bill of quantities (BOQ) and material specifications for procurement purposes.
- Prepare construction method statements and health and safety specifications related to structural works.

2.4. Installation Supervision

- Conduct site handover with the appointed contractor.
- Review and approve contractor's fabrication drawings prior to manufacture.
- Perform periodic site inspections to ensure compliance with design, drawings, and quality standards.
- Verify that welding, bolting, and alignment meet SANS requirements and project specifications.
- Witness load tests or structural inspections if required.
- Ensure all works comply with the OHS Act and relevant safety regulations.

2.5. Completion and Handover

- Conduct a final inspection to verify structural integrity and compliance.
- Issue a completion certificate and as-built drawings.
- Provide a signed Structural Completion Certificate (Form 3) in terms of the National Building Regulations.

3. DELIVERABLES

The Structural Engineer shall provide:

- Site inspection reports.
- Concept and detailed design reports.
- CAD drawings and PDF versions of all engineering plans.
- Structural calculation report.
- Material specifications and BOQ.
- Method statement and safety specifications.
- Final as-built drawings and completion certification.

4. PROGRAMME AND TIMELINES

The Engineer shall submit a proposed programme for design, documentation, and supervision stages, aligned with the overall project schedule. Milestones must be agreed upon before commencement.

5. PROFESSIONAL REQUIREMENTS

- The Structural Engineer must be registered with the Engineering Council of South Africa (ECSA) as a Professional Engineer (Pr. Eng) or Professional Technologist (Pr. Tech Eng).
- Demonstrable experience in the design and supervision of steel portal frames.
- Familiarity with municipal infrastructure projects and public transport facilities.

6. STANDARDS AND CODES

All works shall comply with the latest editions of:

- SANS 10160 – Basis of Structural Design and Actions
- SANS 10162 – Structural Steel Design
- SANS 10100 – Concrete Design (if applicable)
- Occupational Health and Safety Act (Act 85 of 1993)
- National Building Regulations (NBR)

7. HEALTH, SAFETY, AND ENVIRONMENTAL REQUIREMENTS

- All work shall be carried out in accordance with the Construction Regulations of the OHS Act.
- Waste material from fabrication and installation must be disposed of responsibly.
- Environmental impact must be minimised during construction.

This scope of work defines the minimum requirements expected from the appointed Structural Engineer for the Grabouw Taxi Rank portal frame project. Any additional services necessary to achieve compliance, safety, and durability shall be deemed included in the scope.

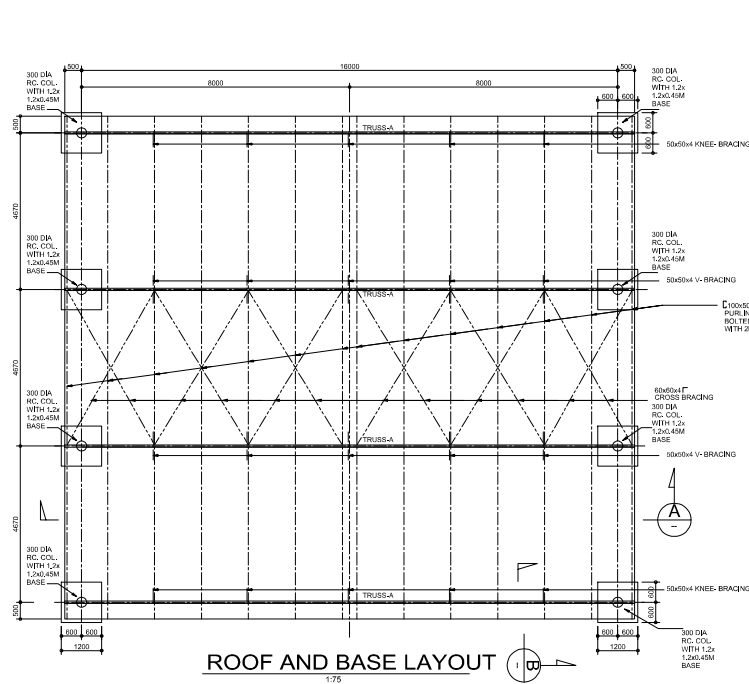

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
