1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Quotations must be completed in handwriting with black ink.
- b) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- c) Prices quoted must be valid from closing date till 30 June 2026
- d) The contract will be for a period from date of appointment until 30 June 2026.
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the MBD 2, MBD 4, MBD 6.1, , MBD 8 & MBD 9 forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation subject to the test for administrative compliance.



SCHEDULE 2: SCOPE OF WORKS

1. BACKGROUND AND CONTEX

Theewaterskloof Municipality requires the provision of CCTV installation and maintenance services at municipal buildings for each town individually, as detailed below along with the corresponding GPS coordinates for each location. The project involves the installation of point-to-point and point-to-multipoint Local Area Network (LAN) to Wide Area Network (WAN) infrastructure to integrate Theewaterskloof Municipality's CCTV closed network into a unified system. This network will cover the entire municipal geographical area, including all remote offices, with centralized monitoring and management at the Caledon Control Room Centre, located in the Caledon Town Hall at 22 Plein Street, Caledon, 7200. CCTV System cameras will capture high quality, undistorted clear imagery of overall activities occurring around the premises, corridors, parking entrances, building entrances etc. The objective is to ensure the reliable supply, professional installation, and ongoing maintenance of CCTV surveillance systems for the duration of the contract, which will run until 30 June 2026.

3. SCOPE

The overview camera specifications will be required to interlink with the Theewaterskloof Control Room

It is imperative that all equipment installed, will be compatible and must link up with the Control Room.

The successful tenderer(s) will be expected to supply, deliver, and install the CCTV Cameras for monitoring and detection of crime related incidents.

Poles and digging of trenches will be supplied by the municipality, if and where necessary.

The items to be procured will depend on the site requirement as and when identified throughout the contract period.

4. CCTV MAINTENANCE PLAN (AS AND WHEN REQUIRED)

The Municipality shall, from time to time, identify sites that require CCTV system maintenance, repairs, or upgrades. Maintenance services shall be rendered by the successful bidder on an "as and when required" basis, in accordance with municipal operational needs.

Prior to the commencement of any maintenance work, the successful bidder shall be required to conduct a site inspection (where applicable) and submit a detailed formal quotation outlining the scope of work, materials, labour, and associated costs.

No maintenance activities may be undertaken without prior written approval and authorisation from the Municipality. All approved work shall be performed in accordance with the original technical specifications, manufacturer recommendations, and applicable municipal ICT and security standards.

The bidder shall also be responsible for ensuring that all repaired or replaced equipment is fully tested, operational, and supported by a completion report and service sign-off by the relevant municipal ICT representative.

5. SITE MEETING AND TECHNICAL COORDINATION

Prior to the commencement of any installation or implementation activities, the successful bidder shall be required to attend a mandatory site meeting with one of the Municipality's senior ICT technicians.

The site-specific requirements, network design, and implementation plan shall be reviewed and confirmed to ensure full integration with the Municipality's CCTV Control room network.

No work may commence on any site until the bidder has completed this coordination meeting and received written confirmation from the Municipality ICT department to proceed.

If the bidder fails to sign this schedule, it will be interpreted that the bidder does not comply with the Scope of Works and therefore will be regarded as being not eligible.
