Quotations will not be accepted if they don't comply with the marking instructions. Quotations must be placed in tender box **No. 2** at the **Main Entrance** of Theewaterskloof Municipality, 6 Plein Street, Caledon by no later than 12:00 on Friday, 15 September 2025, immediately after which the quotations will be opened, and the opening results will be published within 3 days after the closing date on the Theewaterskloof Municipality's website. 1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Quotations must be completed in handwritten non-erasable black ink. Only original documents will be accepted.
- b) Price(s) quoted must be valid for at least sixty (60) days from closing date.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) The contract will be from date of appointment until 30 June 2026.
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose **MBD 2**, **MBD 4**, **MBD 6.1**, **MBD 8** and **MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation.
- f) The successful provider will be the one scoring the highest points.
- g) A Valid Tax Compliance Status Pin Certificate and a copy of your latest Municipal Account or Lease Agreement should be attached to your quotation.
- h) Council may accept a quotation in full, partially or not at all.
- i) Payments will be made not later than 30 days, after the receipt of a tax invoice.
- j) Invoices must not be issued before goods / services have been supplied / rendered.
- k) The General Conditions of Contract will apply to this quotation.
- I) Calculation errors will be corrected by the Municipality by using the unit prices.
- m) If a valid certified B-BBEE certificate or EME affidavit is not attached, it will be interpreted that the preference points for B-BBEE status level or contribution are not claimed.
- n) If a valid certified B-BBEE certificate or EME affidavit is attached and points are not claimed in terms of the MBD 6.1, it will be interpreted that the preference points for B-BBEE status level or contribution are not claimed.

1. CONVEYANCING CERTIFICATE

The purpose of this section is for a duly admitted and practising Conveyancer to issue a Conveyancing Certificate in respect of the different pocket of lands (*listed in pricing schedule*) in accordance with the applicable legislation, regulations, and requirements of the Municipality and/or Deeds Office.

The appointed Conveyancer will be required to:

1.1. Undertake Due Diligence:

- Verify ownership of the subject property/properties.
- Confirm that all conditions of title are complied with or appropriately addressed.
- Ensure that the land is suitable and legally available for the intended housing development.

1.2. Check Legal Compliance:

- Confirm that all statutory requirements are met, if not the process has commenced for the compliance.
- Verify that the township establishment conditions, if applicable, have been fulfilled.

1.3. Issue Conveyancing Certificate

- Prepare and issue a valid Conveyancer's Certificate required in terms of the Deeds Registry requirements.
- Certify that the property is unencumbered for purposes of transfer to beneficiaries and that no restrictions prevent the intended development.

2. REGISTRATION AND TRANSFER

The purpose of this section is for an admitted and practising Conveyancer to undertake all conveyancing-related tasks required for the registration of already-approved but unregistered Surveyor-General (SG) diagrams and the completion of individual property transfers to approved beneficiaries of the subsidy housing project.

The appointed Conveyancer will be required to:

2.1. Registration of SG Diagrams

- Obtain certified copies of the approved SG diagrams and General Plan from the Surveyor-General. (SG number to be provided by Municipality)
- Prepare and lodge the diagrams at the Deeds Office for registration.
- Address any requisitions or correspondence from the Deeds Office until diagrams are successfully registered.

2.2. Opening of Township Register

- Once SG diagrams are registered, prepare and lodge documentation to open the Township Register at the Deeds Office.
- Ensure that each erf is correctly recorded and aligned with the approved General Plan.

2.3. Individual Transfers to Beneficiaries

- Obtain the approved beneficiary list from the Municipality.
- Prepare deeds of transfer for each erf/unit and attend to signatures by beneficiaries.
- Lodge deeds of transfer with the Deeds Office.
- Resolve any restrictions, endorsements, or conditions affecting transfer.
- Track the registration of transfers and respond to any Deeds Office requisitions.
- Issue Individual tittle deeds of the beneficiaries to the municipality.

MBD 2 - TAX CLEARANCE CERTIFICATE REQUIREMENTS
