# 1. Standard Conditions of Quotation:

# The following conditions will apply:

- a) Quotations must be completed in handwriting with black ink.
- b) Prices must be valid for at least sixty (60) days from the date of your offer.
- c) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- d) The contract will be for a period from date of appointment for a period of 12 months.
- e) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the MBD 2, MBD 4, MBD 6.1, MBD 8 & MBD 9 forms which are available on the Municipal Website <a href="www.twk.gov.za">www.twk.gov.za</a> must be completed and submitted together with your quotation subject to the test for administrative compliance.

# 1. Introduction:

The purpose of this RFQ is to procure advanced ICT security software that will protect Theewaterskloof Municipality's digital infrastructure from evolving threats, ensuring the integrity of our business services and the confidentiality of citizen data. The specification of this RFQ is compatible with the current Email system in use by the Municipality. Acceptance of an offer will not constitute a commitment towards future purchases on the part of Theewaterskloof Municipality. The present RFQ will result in the procurement of a service for the protection of the email domain against email impersonation for a period of one year. Therefore, the services of a solutions provider are needed to secure full protection while mitigating the risk of false-positives and allowing legitimate email services to operate without interruption.

# 2. Functional Requirements:

Through this process Theewaterskloof Municipality seeks to protect the email domain (**twk.gov.za**) by ensuring the following aspects/functionality are in place:

- Security: Ensuring no attackers can send email impersonation or spoofing attacks on Theewaterskloof Municipality domain.
- Compliance: Ensuring staff can only send their mail via group approved email servers. This ensures correct record management of all email communication.
- Visibility: Gaining full visibility of all servers, both legitimate and illegitimate, that are sending email from Theewaterskloof Municipality domain.

Essentially improving Theewaterskloof Municipality email delivery and making sure official electronic communications arrives in the intended inbox and not a spam bucket.

# 3. Service Level Technical Support

Bidders must ensure that the proposed solution incorporates clearly defined Support, Service Level Agreement (SLA), and Escalation Processes, outlining response times, responsibilities, and performance standards in accordance with municipal ICT governance requirements.

# MBD 2 - TAX CLEARANCE CERTIFICATE REQUIREMENTS

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

# 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "**price**" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

# 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

#### MBD 9 - CERTIFICATE OF INDEPENDENT BID DETERMINATION
