#### 1. Standard Conditions of Quotation:

#### The following conditions will apply:

- Quotations must be completed in handwriting with black ink.
- Prices must be valid for at least sixty (60) days from date of your offer.
- Price(s) guoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- The goods must be delivered within two (2) weeks work from date of official order.
- This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the MBD 2, MBD 4, MBD 6.1,MBD 8 & MBD 9 forms which are available on the Municipal Website <a href="www.twk.gov.za">www.twk.gov.za</a> must be completed and submitted together with your quotation subject to the test for administrative compliance.
- The successful provider will be the one scoring the highest points.

- Council may accept a quotation in full, partially or not at all.
- Payments will be made not later than 30 days, after the receipt of a tax invoice.
- Invoices must not be issued before goods / services have been supplied / rendered.

- Calculation errors will be corrected by the Municipality by using the unit prices.

perform on the contract, the municipality has the right to purchase from the tenderer scoring the second highest points and if the second highest points scorer cannot perform on the contract, the municipality reserves the right to purchase from the tenderer scoring the third highest points.

## MBD 2 - TAX CLEARANCE CERTIFICATE REQUIREMENTS

It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Services (SARS) to meet the bidder's tax obligations.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
